The trail is 13 km from Rossland Rord to Highway #7 parking lot






1S090Define trail currently 3 routes thought trees. Current trail falling into river. Need to drain wet area and redefine trail away from river bend.

We suggest these trails be blue blazed as a secondary trail. In the future their might be additional trails made or documented as blue trails and interconnected to the Seaton trail.



ATV activity coming down the hydro tower hill from farm lands. Need to post NO MOTORIZED VEHICLE signs









Bridge into Whitevale park needs to be position better and boards added to both ends to make a strong at corner edge. The bridge should be longer and transition into trail better.



3N031Wet section could be re-route away from water pooling areas. People are already making alternate paths around wet sections. Need to re-route and block off old wet trails.



Dirt bike and ATV access around the bridge.

Suggest access be maintained for ATV so they can go from north to south side of the highway#407 overpass. Place NO MOTORIZED VEHICLE signs at north and south entrance to Seaton trail. 2 signs required.
